There are significant profits to be made in property development and there are several types of property development you can undertake. One type is LAND SUBDIVISION. In this strategy the use of land is changed, for instance, from rural to residential or commercial. Another development strategy is the more familiar RESIDENTIAL. Here an existing property can be changed to have multiple dwellings based on the density ratio and meeting planning requirements. REDEVELOPMENT of existing Residential, or Commercial properties is another.

The following are estimates of profit percentages developers can make in various property development strategies:

- a. LAND SUBDIVISION:
30%-to-50%+
- b. RESIDENTIAL(multi unit 20%+) (Multi level – 50%+)
- c. RESIDENTIAL REDEVELOPMENT:
20%+
- d. COMMERCIAL: 30%+
